PASTOR'S MESSAGE

The Rev. Enno Limvere

I was worried that I wouldn't survive COVID when it first swept over the nation. With my fibromyalgia, I am definitely not the epitome of a healthy person. As vaccines came about and new treatments, my worry got a little less. Being in a county that has the highest vaccination rate in the state also helped me to worry a little less. However, there are no guarantees about how life and death progresses. It appears I have survived this, as well a Kileen. For that I give thanks.

We are now in the history making pandemic with over one million people having died just in the United States alone and the cases are on the rise once again. We are still caught in this weird time of wanting to get back to 'normal' while still wanting to be careful while having no idea how we process the deaths and the disruption of our community, our country, and the world. Many of the people who died, died alone. Many of the families who lost loved ones, were not able to gather to do the normal talking, eating, and grieving together even for those who didn't die of COVID. There probably won't be a National Day of Remembrance, such as the one for September 11th or Pearl Harbor Day, though we are still living out the effects of this pandemic and will be for quite a while.

What our nation has discovered about itself in this time will also take time and effort to work through. We really didn't learn anything new, just that we haven't come as far as some believed or as I hoped. We are still a nation that puts profits over people, we still have a good portion who put their 'rights' over the health and well-being of overs, and we still are a nation divided over what is the common good. They are linked together in strong ways and those bonds have not loosened. One silver lining is our service industry has gotten a little more respect and wages have gone up as people aren't flooding back to work for minimum wages.

As people of faith who are called to love our neighbor, we have work to do. We must continue to care for the least of these, to speak for those who cannot speak, and do justice on behalf of the poor and the stranger. We, as a church, cannot accomplish this work alone, but the world cannot accomplish this work without us, and without them. May we continue to do justice, love mercy, and walk humbly with our God.

MINUTES FROM WINTER UCC CONGREGATIONAL MEETING JANUARY 30, 2022 WELCOMING AND REVIEW OF PROCEDURES FOR THE MEETING

Moderator Jenny Delfs called the zoom video meeting to order at approx. 1120 hours. Jenny welcomes all in attendance and read the Congregational Purpose & Mission Statement.

Rules of the meeting were explained by the Moderator. She said the procedures will be overseen by Kevin. Vote was to be determined by simple majority of members attending. With no formal membership records existing, Jenny stated our practice has been that those who affirm the mission and purpose of this church and consider themselves to be members of the church, may participate in voting. She said this policy is "consistent with the beliefs" of this church.

Determination was made that a quorum existed for the current meeting to proceed

CALL TO ORDER

Outline of meeting given by Jenny

Opening Prayer given by Pastor Enno asking for the Lord to lead us in wisdom and be with us in our actions this day.

Communications agreement read by Jenny

Jenny presents agenda, agenda is shown on screen, agenda approved by vote.

Minutes were approved from previous summer meeting in June of 2021, and Winter meeting in January of 2021, with some minor edits

FINANCIAL REPORT FOR 2021

Kevin gave the Finance Report, the balance statement for end of the year 2021, was reviewed. Then the profit and loss page was presented, this showed approximately \$150,000 had been spent, which was about \$14,000, more than what was taken in. Reserves were used to cover those expenses. Repaying a \$10,000 loan we received last fall from the government was also discussed. Kevin felt there was a chance we would have this debt forgiven by the government.

Proposed budget of \$153,000 was presented, minor amendments were made in five categories. Kevin did not anticipate the need to take more money out of the endowment account, which has a current market value of about \$198,000, but said there was a possibility this might be necessary.

The loan for the roof was discussed and the fact it would be beneficial if the church could make efforts to pay some of the balance early to reduce the interest. Kevin said the interest rate, currently at 5%, had recently been renegotiated to a more favorable rate but could not be done again for two years.

Budget was approved by vote of members

VOTE ON CHANGE TO CALLED PASTOR

Jenny gave a summary timeline of previous pastors at this church leading up to the Board of Directors designating a Search Team who hired Pastor Enno as a Designated Term Pastor in 2022, under a two-year contract. Based on his successful performance the first year of the contract, the board felt it was now appropriate to offer Pastor Enno a permanent Called Pastor position. Unlike a Term Pastor, this action requires approval of the congregation.

A motion was made by Don Davidson and seconded by Nancy Starr that we proceed with this action. An overwhelming approval was reflected in the vote of the membership.

Jenny welcomes Called Pastor Limvere who accepts the mandate (God Rest His Soul)

BOD 2021 ANNUAL REPORT

Submitted by Moderator Delfs who begins by announcing in June she will be stepping down from her position as moderator but will continue as a member of the board. She appealed to the congregation to search their hearts as we consider a replacement for this position.

Jenny continues with an overview of board activities in the past year, stating we strived in a time of pandemic, to deal with the challenges and to remain vibrant and encouraged by the works being done. Specifically noted were board actions involving the successful hiring of a new Called Pastor, passing necessary Bylaw changes, dealing with difficult budget situations as well as supporting building and grounds needs. We have also hired another wonderful office manager, resolved the bookkeeping situation, while still having time to welcome new members.

PASTOR REPORT

With renewed spirit Pastor Enno stated how blessed he felt to become our Called Pastor and how thankful he is to stay and continue his work. He expressed his belief that our church has changed in the past year and, as the healing continues, will continue to move forward.

BYLAW CHANGE, RE DEFINITION OF QUORUM

Current Bylaw III #2 & #4 were amended to define quorum, for purposes of calling a congregational meeting and vote determinations, as *members in attendance numbering at least 50% of the average weekly worship attendance.*

The Bylaw change was passed by overwhelming majority.

Don suggested a formal membership list be produced to determine how many "members" our church has. Considering the term "member" has been a sensitive issue, the action was not taken up at this time.

WELCOMING NEW MEMBERS

We welcomed new members who wished to formally join with us, greetings to Steve Aldrich, Bruce Tyler, and Linda Noble.

BUILDING AND GROUNDS COMMITTEE UPDATE

John Bottger used this opportunity to draw our attention to all the work that has been done by Jeff Kern to keep the church building functioning at minimal expense. Many thanks to all you've done Jeff.

Also, John acknowledged the many needs the physical church is presently facing and will have in the future. With the help of the congregation, he is seeking a "vision," a plan for future projects, and discussion as to how this all can be made possible. Enno added we must determine to best way to approach our needs and to raise money to address issues.

CLOSING PRAYER

Enno gave thanks to all who were involved in the process today and gave blessings to the leaders of this church and all gave their time and support to its success.

FINAL DISCUSSION

Relating to the meeting, issues were discussed shortly afterwards regarding a suggestion a midyear review of the pastor's performance for the first year may be needed. Also discussed was the proposal to take a more thorough look into membership situation at the church. Jenny felt the pastoral review change could be taken up at the next board meeting and wholeheartedly agreed with Pastor Enno that the membership definition issues be addressed after June of this year with a new moderator.

Enno has had initial discussion with a massage therapist (N. Sobanja) looking for office space – if this works, she would need space 2 days a week. Piano teacher will be leading Explorer's Club this summer, not teaching lessons.

<u>Pastor report</u> – no formal report this month (vacation and illness) but Enno reported on the success of the Earth Day Fair at Community Center, upcoming plans for Pride. Congregation volunteers lead last Sunday's service.

Old Business:

- 1. Pass through funds Pastor search funds used to get computer needed for worship zoom, rest in general fund. All but \$500 Thanksgiving funds will be turned into food cards (Johnsons, COOP) to distribute to community members with food insecurity via food shelf, social services and direct contact. Meeting with past travelers to Chiapas re: potential use of funds yet to be scheduled.
- 2. Mutual ministry goals for 2022-23. Jenny would like to present BOD goals at summer meeting. Reviewed work done on this so far. Enno suggested we come up with 3 main goals. Board members are to list 3 goals email to each other by 5/31 so can make final decision at 6/14 meeting.
- 3. Safe church/ abuse prevention policy refinement in progress.
- 4. No news re: cemetery property.

- 5. No news re: possibility of vehicle charging stations.
- 6. Explorer Club to use South Room for storage, shelter from rain
- 7. Membership list discussion tabled for now.
- 8. Reviewed proposed agenda for Summer Meeting 6/26. No additions. Will be sent in for June newsletter.
- 9. Nomination committee has list of 8 people that are being asked to consider joining the Board. 1 or 2 have expressed interest. Nominating committee will have conversations with candidates and come up with slate of 4 candidates for election to BOD to be presented at summer meeting. Current Board members Carol Winter, Tom Yuhasey and John Bottger are up for re-election and wanting to stay on.
- 10. No responses to janitor position posting. Gwen Mattice is willing to help in June if needed after Marie leaves.

New Business:

- 1. Building use/worship in time of covid. Will continue to hold services in sanctuary if transmission remains in yellow zone. Go back outside starting 3rd Sunday in June (Pride 1st Sunday and Enno at MN UCC annual meeting 2nd Sunday). Zoom option or watching taped service always available. If community goes to red zone transmission, service will be outside or zoom depending on weather
- 2. New mission statement goal:
- a. Breakout groups at church service 5/22 to start conversation. 2 questions: 1- what makes this church come alive? 2 what needs in this community/country/world do we feel called to respond to? Enno will set up small groups and facilitators for 3 groups.
- b. Further discussion 6/26 after formal summer meeting to look at responses and develop a discovery team of 4-7 folks to work on revising/ refining mission statement. Mission can be used then to set priorities for building committee and other groups. Goal is a vote on new mission statement at Winter Meeting 2023.
- 3. Option for BOD or congregants to attend MN UCC annual meeting June 10-11 in person at St Joseph, MN or via zoom. Peace cranes will be going.

Speakers, process announced for September all-church summit by Staff Reports | published on May 19, 2022

Details are emerging about a major United Church of Christ "summit" set for September.

"The Space Between: The Emerging Church in a Post-Pandemic World" will be held online Sept. 19-21. And people who can come to St. Louis will be able to take part in the summit together, in person.

Registration, open to all, will begin in early June, said UCC Chief Strategy Officer Cheryl Joseph Williams, who is coordinating the summit. She serves on the staff of General Minister and President John Dorhauer, the event's convener. She said registration fees will be announced at that time.

Williams said the summit's goals are to:

"Acknowledge what we've lived through" during the COVID-19 pandemic.

"Recognize the innovative ways we have survived and, in many places and ways, thrived."

"Capture these ideas and invite one another to work together in further exploration of what fits now, where we need to stretch ourselves, and how we build capacity to resource the church's needs as it evolves."

Event format

The event will revolve around eight prerecorded "TED"-style talks, which Williams is calling "provocations." Each of these — 10 to 25 minutes long and given by a UCC leader — will aim to provoke "ingenuity, creativity and conversation." Participants will view the talks and respond in large- and small-group conversations via a virtual event platform, Pheedloop.

Registration will open in early June at this web page.

Williams said the event's planning team will ask participants in advance about "the issues that matter most to them." She said the event will foster conversation on those topics by using "unconference" techniques, such as world café and lightning talks.

In addition, she said, "informal, self-formed groups" will be available for people "who find themselves drawn together by common issues, ideas, opportunities or challenges." The event will also include "worship and spiritual reflection components at regular intervals."

Featured 'provocateurs'

Two UCC ministers will give keynote presentations:

Opening — Monday, Sept. 19: Jacqui Lewis, senior minister for public theology and transformation, Middle Collegiate Church, New York City.

Closing — Wednesday, Sept. 21: Laura Everett, executive director, Massachusetts

Council of Churches.

In-person participants will gather for those keynotes at the Hilton St. Louis Airport hotel. (The event has been moved to St. Louis from the originally announced host city, Cleveland.)

The middle day, Tuesday, Sept. 20, will feature these ministers as presenters:

Damayanthi Niles, interim academic dean and professor of constructive theology, Eden Theological Seminary, Webster Groves, Mo.

Cameron Trimble, president and CEO, Convergence.

Michael Malcom, founder and executive director, The People's Justice Council and Alabama Interfaith Power & Light.

Juan Carlos Huertas, minister of proclamation and practice of justice, First-Plymouth Church, UCC, Lincoln, Neb.

Patrick Duggan, executive director, Church Building & Loan Fund.

Jamesetta Ferguson, senior pastor, St. Peter's UCC, and president and CEO, MOLO Village Community Development Corporation, Louisville, Ky.

David Vásquez-Levy, president and professor of homiletics, Pacific School of Religion, Berkeley, Calif.

In-person sessions that day will be at Eden Theological Seminary. Transportation between the Hilton and Eden will be provided. Williams said a room rate of \$125 per night will be available at the Hilton for summit participants who book by Aug. 19.

'Play space for ideas'

As ideas and strategies emerge during the event, participants will discuss "what we each bring to the table to help us get there," Williams said. "We hope to quantify these gifts and access paths to them by end of the summit."

"I believe that the Holy Spirit has shown us that the church can and will thrive under any circumstances," Dorhauer said. "I also believe our leaders have discovered, even through the worst of the pandemic, new pathways to growing the faith.

"It is my hope that over three days in September we will open up a conversation about what we have learned, what we imagine is possible, and what we are willing to commit to as co-creators of the church's future. We have among us leaders who have already designed or imagined ways to build on past successes, and who are willing to incorporate new learnings in order to co-create a vital and life-giving mission for the church of tomorrow. We want to open up the play space for their ideas to flourish with colleagues who are willing to play along with them
